

## **Bank Asya's Net Profit for 2009 Has Reached TL 301 Million**

Bank Asya's net profit after taxation, which was TL 247 million at the end of 2008, has increased to TL 301 million in 2009. Bank Asya's pre-tax profit has reached TL 378 million.

According to the written statement made by Cemil Özdemir, the President and CEO of Bank Asya, the Bank has continued to grow profitably in 2009. The statement includes Bank Asya's year-end figures for 2009. The net profit of Bank Asya which was TL 247 million at the end of 2008 has increased to TL 301 million growing 22% at the end of 2009. By year-end 2009 the shareholder's equity has increased to TL 1.708 million growing 22%, total assets have increased to TL 11.609 million growing 43% and funds collected via current and savings accounts have increased to TL 9.137 million growing 56%. On the other hand, total cash loans have reached TL 8.063 million and total non-cash loans have reached TL 8.886 million.

In accordance with its controlled and restrained growth strategy, Bank Asya has raised number of its branches to 158 increasing 6% and number of its employees to 4.074 increasing 7%. While Bank Asya revised its internal-systems, infrastructure works and improvements of processes have also been accelerated in 2009.

In the written statement made by Cemil Özdemir, the President of Bank Asya, it is stated that Bank Asya, which carries out its financial activities for 13 years, has maintained its success and continued investments in spite of

global economic crisis. Cemil Özdemir pointed out that whereas the total cash loans of Banking Sector increased 6,9%, the total cash loans of Bank Asya increased 34% during the same period. He also noted that with its reassuring structure Bank Asya continued to finance the real economy in 2009, too.

He stated that it is deduced that the worldwide financial crisis is getting over and Bank Asya always takes the side of its customers and its support for them will continue.
